# **Expedited Gotch Criteria for Discharge Approval to Congregate Setting/High Risk Settings**

- AFB smear negative x 3 AND low risk for drug resistance, e.g.
   Xpert Rif resistance not detected;
  - Criteria for d/c 3 days of multidrug anti-TB therapy
- AFB smear positive AND low risk for drug resistance, e.g. Xpert
   Rif resistance not detected
  - Criteria for d/c 14 days of multi drug anti-TB therapy

# Implementation of "expedited Gotch"




- Outside, TBCP surveillance team, after hours Duty Officer (MD) for LA County DPH addresses after hours/holiday calls for the following:
  - Disease Control
  - Bioterrorism
  - Hospital Facilities Inspection
- Updated our existing survival guide for TB for the AOD to include the expedited Gotch criteria
- Provided training at bimonthly AOD meeting; up to AOD to determine whether to use the expedited Gotch criteria

# Hospitals retain capacity for TB patients through the Public Health pandemic




Figure 3. Evaluations for suspected TB by hospitals in LAC, California 2017-2022.



### **Impact**

- Only activated for winter of 2020; subsequent surges have not required expedited approval.
- Have reverted to routine Gotch criteria but have a workflow for converting to expedited Gotch if hospital bed shortage ensues
- Have not evaluated whether early d/c to high risk settings had resulted in transmission
- While bed capacity was limited for elective admissions, e.g.
  desensitization of anti-TB drug, the TBCP experienced
  remarkable cooperation and commitment to retain beds for TB
  patients throughout the pandemic

# Mobile Vaccine Therapeutics Team Timeline COUNTY OF LOS ANGELES Health

- Clinic Services (CS) Team that started out as a COVID-19 testing team for skilled nursing facilities in mid 2020; supported by COVID-19 funds with contractors
- Expanded to provide COVID-19 vaccination in skilled nursing facilities in early 2021; then began to provide COVID-19 vaccination in shelters for people experiencing homelessness (PEH).
- Team added provision of COVID-19 treatment (telehealth) to provide ambulatory COVID-19 antiviral therapy to patients
- COVID-19 funds will be ending in 2023; CS beginning to have some success with billing for services; team success (physician, nursing, administration) may translate to local positions
- LA County shelter guidance recommends annual TB testing for PEH in shelters – carrying out these recommendations is challenging for some shelters. Vaccine apathy in shelters motivated MVT team to expand TB testing in shelters

#### Translation of TBCP team shelter workflows to MVT



MVT field team needed designated clinician to determine need to isolate individuals with symptoms or more complex TB testing history

Privileging of MVT and telehealth physicians for latent TB infection



Mechanism for providing notification of results to shelter clients and if TB test positive, more time for evaluation to obtain CXR for asymptomatic shelter clients, to the shelters

Homeless Management Information System (HMIS) data system clearance; HIPAA compliant

Lost to follow up? HMIS flagging; internal (DPH) vs. external user HIPAA complicant notifications



Linkage to plain film CXR for asymptomatic clients via coordination with CS chest clinics located nearby




